Since we had an Employee test Positive, we now have to test ALL residents for COVID for the next 2 weeks. It also means that we will NOT be open for Visitations until the 2 weeks of testing have been completed and ALL residents are Negative.

Prince George's County remains in Phase 2 at this time. We perform routine screenings for Staff and any Essential Vendor for signs and symptoms of illness prior to entering the building.
